3. **Public Participation (10 minutes)** – an opportunity for parishioners to briefly raise matters of concern and hear from County and District Councillors

Newly installed bench on corner of Red House Farm Lane and The Street is lovely

Group of Churches within area will be holding a Christmas Tree Festival at St Andrew's Church in Alderton Friday Nov 29<sup>th</sup> to Sunday Dec 1<sup>st</sup>, currently have 18 different organisations, would like the Bawdsey Parish council to consider having a tree, will be a minimal charge of £5.00 to cover expenses. Tree or Wreath can be own or organisers can provide, individual trees will need to be cleared after weekend, we would need to decorate, have own pot and can only use battery lights, theme is 'Darkness out of Light', not chocolate or Disney, some people are providing an artificial tree, another organisation is going to knit one. Cllr RoTh suggested getting a sapling, with a note stating BPC – 'Wintertime Planting for Nature', could then plant after, all in agreement.

Has been trying to contact with newly appointed Cllr Jenny Riddell-Carpenter to invite her for a day to show around the peninsula and also attend joint peninsula meeting (28<sup>th</sup> Nov at Sutton), to hear about the common issues parishes have in the area, would like to work with her, but so far have not had a response, not even a holding reply.

Comment: - Would like to mention the state of the roads and the white lines, drove back when it was foggy and could not see anything on roads. Cllr JaMa, agrees are bad, horrific accident in Hollesley last week and has been over a week and still the road has not been done, diesel needs specialist equipment, softens tarmac, may need to replace road, but if was a main road, would have been sorted within a couple of hours, at Shingle Street the road is splitting and still waiting for something to happen. Concern raised for shop and business in the area, whilst road closed.

Comment: - Has been a traffic enforcement officer at Bawdey Quay on a Sunday, issuing parking tickets, would be interesting to have a report on how many fines have been issued.

Planning – Eyke, planning accepted for 65 houses, now need to look at the enforcement of the conditions by highways, maybe an opportunity to break up straight road, big problem with heavy traffic and speeding, trying to articulate resident views and environmental protection, builder needs to be mindful is a residential area. Flagged a planning enforcement issue by Sutton Heath, owner works within permitted develop rights, does not have permission for an official campsite, had a sign removed, just put it further back from highway.

Waste – big changes happening, previous government was working on how to homogenise waste collection across country, implementation, is where council have a choice, and ESC are looking at more bins and changing how often waste is collected, going forward there will be 5 bins, 2 recycling bins, (1 card and paper, other tetrapaks, glasses, plastic containers), green bin, still pay for, normal refuge bin and a food bin, food bins will be a weekly collection, with refuge bins collected every 3 weeks, problem is with certain properties, such as Victorian Terraced Houses, where do all the bins go, when Cllr JaMa was in charge of waste, did consider compartments within blue bins, rather than an extra bin. Will need to procure new equipment for the changes, i.e. new refuse trucks, glass should go into bottle bank, as that will be recycled into glass, if collected at roadside with go to recycling centres, where could be contaminated and will then go into aggregate, Tetrapaks and Reusable Coffee Cups are not recyclable in a particularly efficient way, Tetrapaks are difficult to recycle, have a membrane inside, needs to be split away from cardboard, very energy intensive process, only plant able to do is in Yorkshire. Would like to see more campaigns and discussions about waste reduction. especially food, there is an opt out choice for villages, who could look at central points for collection. Unsure about the 3 weekly collections, especially if hot weather and people have nappies or animal waste.

Comment: - Will council tax rates be put up to pay for new system? Cllr JaMa unsure at moment if council tax will go up, no extra funding coming from central government.

Still a lot of things to consider and overcome, will continue to monitor and report back.

Question – Fly tipping, is it still reported on ESC website, has been a couple of issues lately. Cllr JaMa, please do report on website and flag with him, he will make sure it is removed and follow up if there is an issue, sometimes will get a bit funny if on private land but will put the case forward if would cause contamination, e.g. fridge, more difficult to argue case if litter, but will try.

Possibility of a house swap for residence at School Meadow/Orwell Development, ESC is objecting, stating needs to go back to Gateway but CLT have advised this is not necessary as would come under Cascade level 3 and is not a void, Orwell have asked for BPC to support swap, there were no objections from Councillors, clerk to write and advise Orwell, proposed by Cllr RoTh and seconded by Cllr MiLo, Cllr JaMa has said he will discuss with ESC if an issue remains with housing at ESC

Email received from Highways via Andrew Reid, unsure of the perspective they have taken photos, i.e. standing on the corner as opposed to sitting in a car at the junction, would the line of vision be different, Comment, cars parking on side, may also impede someone's view. Cllrs now feel this should be forwarded to Bromswell Parish Council, as this is within their boundary and see if they would like to take it further.

Need to be mindful of where cabling in this area, Cllr AnRo, does have a plan of this area from when a sign was being considered.

# Email received from concerned resident on report of two serious crimes in area.

This very much a police matter, it is our understanding that there have been no further incidents since July and believe the matter is soon to be resolved. Clerk to write to resident and advise

b. CIL - Receive an update.

Cllr AnRo circulated prior to meeting a proposed list of work that could be carried out through village to increase safety for all road users, following this proposed list, Cllrs, RoTh, ClWa, MiLo, SuTa and SaMa walked the village with the list in mind, what would be in keeping with the village and the next point of actions. When Cllr's walked village noted most cars slowed down, did also highlight where there is lack of vision at junctions, found a 30-mph sign in hedge, not visible to road users. Key points from list discussed: -

White Gates at entrance to village – Looked at land available either side and thought about the costing, feel will need ongoing maintenance and questioned if there are enough volunteers to upkeep them, could we look at alternative sign, Alderton sign has 30 above, also asked if could we have white markings, same as Hollesley? Clerk to enquire and see if this is possible and source alternative signs.

Hedges – Found when walking round, hedges are encroaching and people have to walk further into the road to go around them, discussed possibility of getting a company to cut all hedges back to where they should be and then pass responsibility to landowners for them to continue to maintain every year, need guidance from highways as to the legal wording and if this is permissible. Will reclaim more road and make safer for pedestrians. Clerk to contact SCC Highways and Cllr RoTh to get quotes. Hedge at East Lane, landowner has given permission to cut hedge back, just need to speak with tenant to advise and check this is OK with them, will give more sight at junction with The Street and allow people to walk off road.

Pink Bitmac – All in agreement this would not be in keeping with the village.

Road Markings (30 Roundels) – All need re-painting and an extra one needed by Orwell Housing Development. SCC need to look at all marking, especially central line reservations, clerk to contact Highways and ask for this to be completed.

# Warning Signs

- Beware of Children School Signs at 2 locations: a) on North bound corner of Ferry Rd near High House, & b) on S. bound B1083 near entrance to the Recreation
- No footpath /Beware of Pedestrians or Shared Road space/ Beware of Pedestrians. Positioned just S. of Pitcairn Cott (No.42) where Alderton footpath stops.
- Road Narrows, required on B1083 south bound, just south of East Lane Junction

Need to be mindful of having too many signs, may be better to have just key signs in key places, clerk to cost signs and bring to next meeting and maybe review road once hedges are cut back.

c. Village Hall and Recreation Ground Committee update (Cllr. Tod Heyda)

One meeting held since last Parish Council meeting.

Funding has become successfully sought for replacement of playground fencing

Following sickness, the grass is now having regular cuts

Volunteers undertook a clean-up - beginning of September - 7th

Garage sale successful – although final figures unknown

POPUP PUB - lacked PGL attendance due to another function, but costs appeared to have been covered, another one is planned after Halloween.

Another member of the group has resigned, moved to Hollesley - now have two vacancies New chairs purchased for village hall

Recreation Ground - now has new metal shed - and tents for the Fete are better organised with 2 new ones purchased.

- d. Coastal Matters: Updates on
  - i. Coastguard report (Cllr. R. Thurkettle)

Had a shout for three people on jet skis, two of which had broken down, they asked how they would recover them, were advised will need to be done by sea, asked if could access by land, advised no, private, warned landowner, two hours later they came with recovery truck and winched them up, this part of the cliff has now collapsed into the sea. Still a lot of people walking along the cliff, going down to the beach, mainly local people.

August was the busiest in history, 7 shouts in 4 days at Shingle Street, had people trying to swim across from Felixstowe Ferry to Bawdsey Quay and being swept out, people were cut off on the shingle banks, watching the sunset. Short on numbers. Currently team of 8, 4 people have retired, have 2 new members starting 1<sup>st</sup> January 2025, still leaves 2 people short, so actively looking for volunteers locally.

ii. Deben Marine Centre (Cllr. Heyda)

Visitor numbers appear to be slightly down on last year - but better uptake recently with the improved weather. New tide gauge has been installed, as the previous one was stolen. Review to take place in mid-October, which Helene Burningham is due to attend

#### Weather Station

Attended meeting with the District Cllr and other parties regarding weather station, plan is to resite the mast away from its current position on PGL land and move to DMC, currently completely blanketed from North through to the South by trees. Comment – Unsure if it is sited at DMC, would it be open to vandalism, readings would probably only be for estuary, feel best place would be to put it up on A site if could get landowners permission, allowing to get weather from all directions

#### e. Speedwatch

RoTh, would like a solar panel installed on current SID, as very hard to keep changing batteries, will cost this and come back to council for approval. Would then like to move around village once have solar panel, currently three positions in village that have poles installed.

# g. Update from School (Cllr M Locke)

School have decided to apply to join a Multi-Academy Trust, Tilian, proposal was ready before general election, felt MAT had more understanding and sympathetic about education matters and offered more support for the Head, interviewed two trust and Tilian came across as a good education organisation, all current schools are similar to Bawdsey, small village schools.

Governors, currently have Judith Mason as chair and Teresa Moriarty is vice chair, who were imposed on school from local authority as previous chair resigned, puts school in unusual position of both chair and vice being consultants for local authority, is a temporary arrangement, were both helpful in getting school through recent Ofsted inspection and very good at laying out procedures, when go to MAT, they will step down, will need to find a new chair of governors soon, also two other vacancy, someone from church, Simon Cake appointed, but need someone else from church of England, also vacancy for parent. Good number in under 5's.

# h. Emergency Committee (Cllr. R Thurkettle)

Have two new members, all members have undertaken training about current regulations, on what can/cannot do, behind in getting survey out re finding out what people's skills are and who is vulnerable, pushing to have this done by end of year.

# i. Green Agenda – Trees and Hedges

Chris Mann has kindly given BPC an IBC tank for watering new trees & hedge planted along Manor Drive, existing 1/2" diameter tap makes for very slow work, and need to upgrade to 3/4" bore, would like agreement to spend a further £50 of green budget on buying new 3/4" outlet tap, 10m hose and handgun to make it more usable, proposed by Cllr ClWa and seconded by Cllr RoTh, all in agreement.
